1. Call to Order: Meeting called to order at 6:30pm. Amy asked that the record reflect that she started on time.

2. Call to Community: Spalding Wall, read "Moving Forward Looking Back", by Caitlyn Grey

3. Congregant Comments: none heard

3. FSC Thank Yous: Spalding thanked incoming and outgoing board members.

4. **Nominating Committee:** Shellie Jeffries made a motion for the new slate of officers: Spalding Wall- Chair, Steven DePolo- Vice Chair, James Taylor- Secretary, Tim Creamer-Treasurer, Kristen Mayer-Member at Large. Motion passed unanimously.

6. Governing Board Minutes: James moved to accept the November 27, 2023 minutes. Cele seconded, motion passed unanimously. James moved to accept the minutes from the special Governing Board meeting Dec. 10, 2023. Tim Creamer seconded Motion passed unanimously.

7. Finance:

8. Annual Giving Campaign:

9. Bell Tower / Facilities updates:

Also, while there are grants that are available for bell tower restoration, we have already started the process, so we are too late to qualify for these. Also, we are waiting for the contract. Building Audit

Bell Tower Fundraising

Cele asked about impacts to the fundraising with Christophere leaving.

12. New Business:

Christopher leaving:

Spalding felt that we needed to discuss interim ministry and other issues which we will face soon. We do not need a search committee to hire an interim. The board will hire this position.

Geoff said that he thought we had an interim minister in Jodi.

Spalding asked Rev. Jody to speak on this.

Rev. Jody replied with some resources and advice on hiring an official interim minister... -Hire someone who has been specially trained for interim ministry

Cele spoke on her experience of having a specialized interim minister.

Rev. Jody replied that we should begin with a process of putting together a transition committee to "say goodbye well". This committee should represent as many church groups as possible.

Tim said that we should speak with the staff about the transition and urge these folk's to stay and go through this with us.

Kristin said that before voting on a committee we should speak with folks on who might be interested.

Religious Committee

Spalding said Christopher was originally going to work through summer, but with his leaving, he would work with the religious services committee (Carol) to get a summer speaker series together instead.

Board opening:
